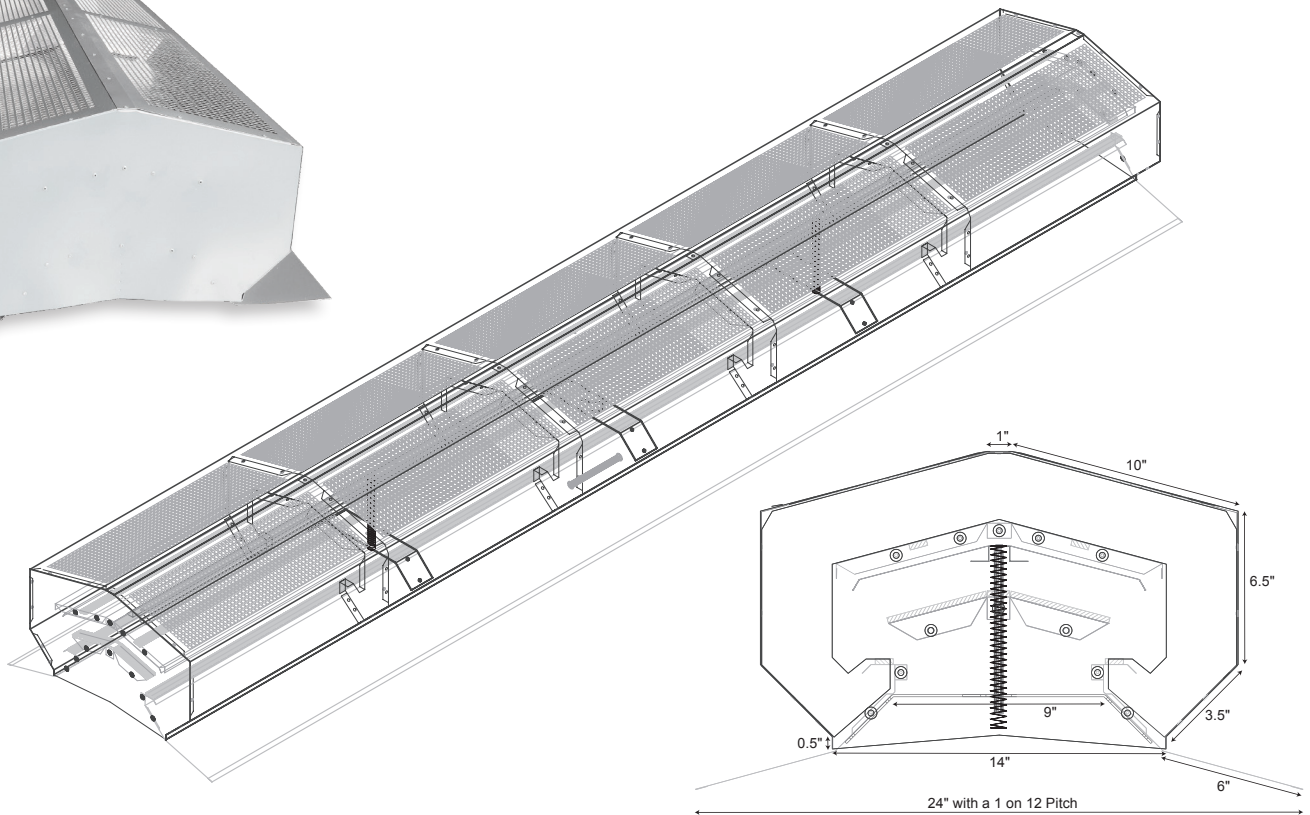
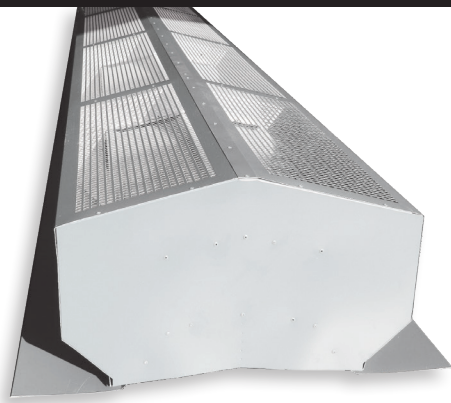


COMMERCIAL RIDGE VENT



Size: The Mueller commercial ridge vent is a 10 foot unit, available in over 30 designer colors.

Design: Our commercial ridge vent design is meant to enhance the appearance and performance of metal roof systems. Mueller ridge vents are made to match the roof slope and color to maintain a consistent appearance while ventilating areas under the roof.

Construction: A Mueller commercial ridge vent is factory assembled for the customer. It is produced from 12, 24 and 26-gauge, grade 50 steel (50,000 min KSI yield point) for a durable, long life while exposed to the elements.

Operation: The vent is capable of being opened and closed via a chain. The damper is spring loaded to remain in the open position until the chain is pulled down and locked in the keyway, which is cut into the vent's support bracket. This vent is not designed to be used with a continuous vent operator kit.

Finish: Steel parts match Mueller roof type and color finish. All Mueller paint types and colors are available using AKZO Nobel coatings.

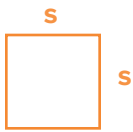
Benefits of Ventilation: One of the most overlooked components of design and installation of architectural roofing systems is ventilation. A properly engineered ventilation system using continuous ridge vents, in conjunction with an under soffit intake and endwall louvered vents, will provide air movement through the roofing system to remove air. Convection removes summer heat, which reduces cooling bills and extends the life of the roofing system. In winter, proper ventilation will assist in the control of condensation that can lead to problems such as rust and insulation degradation.



HOW TO CALCULATE MUELLER VENT AIRFLOW

Usually, when we have this conversation we talk in FSA (*Free Surface Area*), which is the size of opening the venting structure provides to allow air to move from within the structure to the outside of the structure.

Example: If you cut a 2 inch by 2 inch square opening in a roof, you would have a 4 square inch opening ($2 \times 2 = 4$). This would give you an FSA of 4 square inches.



$$\text{Area} = s^2$$

Area = length x width. For a square, the length and width are the same.

For a typical square vent found on many homes or buildings today (which is fed with a 3 inch diameter pipe), the FSA would be equal to the smallest of the free surface areas of the pipe or the opening around the square cover. Usually the smallest area is the pipe, so the FSA would equal the area of the 3 inch diameter pipe, measured below:



r = radius (distance from the center of the circle to point on the circle)

$$\pi = 3.14$$

$$\text{Area} = \pi r^2$$

$$\text{Area} = 3.14 \times 1.5 \text{ inch} \times 1.5 \text{ inch} = 7.065 \text{ square inches} = \text{FSA of the vent}$$

Approximate FSA of each Mueller vent product:

- Mueller commercial 10 foot ridge vent: FSA = 885 square inches
- Mueller utility 10 foot ridge vent: FSA = 240 square inches
- Mueller low profile 10 foot ridge vent: FSA = 166 square inches
- Mueller 6 foot by 3 foot endwall louvered vent: FSA = 410 square inches
- Mueller 3 foot by 3 foot endwall louvered vent: FSA = 205 square inches
- Mueller 2 foot by 2 foot endwall louvered vent: FSA = 89 square inches
- Mueller 12 inch by 18 inch endwall louvered vent: FSA = 35 square inches

If materials or workmanship are deemed defective per generally accepted industry standards, Mueller, Inc. will provide one of the aforementioned remedies within 90 days from the date notice of defect is provided to Mueller, Inc.
